2. For the office of First Vice District Governor, District A9:

- (a) Secure the endorsement of his/her club or a majority of the clubs District A9.
- (b) Currently be serving as 2nd Vice Governor in District A9.

*** Only in the event the current 2nd Vice District Governor does not stand for election as 1st Vice District Governor, or if a vacancy in the position of 2nd Vice District Governor exists at the time of the District Convention, any Club member who fulfils the qualifications for the office of 1st Vice District Governor or 2nd Vice District Governor and who is currently serving or has served one (1) additional year as a member of the District Cabinet shall be an eligible candidate.

3. For the office of Second Vice District Governor, District A9:

- (a) Secure the endorsement of his/her club or a majority of the clubs in District A9.
- (b) Have served or will have served at the time of taking office for a full term or major portion thereof as:

(1) President of the Lions Club of _____ in the Lions year _____ / _____
and a member of the Board of Directors of the Lions Club of _____ for no
less than two (2) years. _____ / _____ and _____ / _____.

and as

(2) Zone Chairperson or Region Chairperson or Cabinet Secretary and/or Cabinet Treasurer in the

(3) With none of the above being accomplished concurrently.
