Tax Exempt Status: Immediate Attention!

Beginning three years ago, organizations were required to file an information return, an 990-N, if the gross receipts for the organization were under \$25,000; organizations with gross receipts more than that are required to file the 990-EZ or 990. To find out more information on this, go to the irs.gov website, select the topic "File 990s by Oct 15" and you will see a list of organizations by state that haven't filed in the past three years.

The following list of clubs in 5NE is on record as not filing the 990-N postcard with the IRS: Region 1-Bowdon; Region 3-Pettibone, Robinson; Region 4-Larimore; Region 5—Braddock, Fredonia, Lehr, Zeeland; Region 6-Davenport, LaMoure.

Region and Zone Chairs should contact the club leaders and have them file electronically by October 15 to get back into compliance.

An evening filled with a variety of events took place at the Kulm County Club during the Kulm Lions Annual Steak Fry. About 90 Lions and friends joined together for the annual event including the surrounding communities of Jamestown, Edgeley, Ashley, Wishek, Gackle, Fredonia and Lehr. The winners of the meat auction were Dennis Schock of Ashley, David Schwigert of Edgeley, Mary Zenker of Jamestown, Randy Klusmann, Sybil Anderson and Gordon Irion of Kulm. A Zone meeting was held, consisting of the surrounding communities, of which Lion leaders were in attendance including Lion District Governor, Robert Littlefield, Moorhead, Region Chairman James Ruff, Lehr, and Zone Chairman, Arlan Burkman, Edgeley.

The Lions have completed the summer ditch clean up while making sure all the rinds were picked up from the Lions watermelon feed during the Kulm WindFest days. The Vision USA-North Dakota project is currently underway which is a program designed to assist the working financially disadvantaged that they have access to eye care and if needed, eye wear. From its inception, the Lions Club has been focused on assisting those with impaired vision through support of Guide Dogs for the Blind and handicapped, the Lions Eye Bank, the recycling of glasses, supporting Sight First projects as well as assisting those on a more local level through Vision USA. This is a "Year Round" project and urges anyone that may be financially unable to acquire an application form through the school or any Lions member. The total donations from North Dakota Lions for 2010 (as of 8/31/10) are \$6,266.00 with 147 applications approved and 20 under review.
